- Applicant to confirm when an alternative building has been found for the workshops as Panel want to ensure full access to the project
- Applicant to forward a copy of the evaluation for the pilot scheme, once available
- Panel asked the applicant to confirm how they connect with Phoenix Enterprise Centre around employment support
- Panel noted that if long term support was not forthcoming, any additional support from the Fund would be subject to a full application

Panel **deferred** the grant request and requested the following information:

How will the applicant ensure the apprentices are job ready? Where are the courses?

- Who will supervise the apprentices? How would the Ranger support the apprentices and where would he and they be located?
- Applicant to provide clarity on potential funding from college and the impact on project budget
- How will the apprenticeships be advertised to attract and ensure Copeland beneficiaries?
- Why are Sustrans not inputting any funding themselves?
- This is a project for two apprenticeships. Should one of the apprentices leave part way through will another apprentices be able to step in and continue? Will the project fail to complete if one apprentice should leave?
- What is the sustainability plan for this project? Is there a guarantee of employment for the apprentices from Sustrans or other partners to the scheme?
- What is the maintenance plan to maintain the route once this project is complete?

#### 7. Projects with less than 60% scoring

**Elements: The Diverse Aging Festival Outreach Cumbria** 

Application no: 960434

**Grant Request: £23,000.00** Whole Borough Capital

Application scored 26/60 (43%) at appraisal. Panel agreed with the scoring on the project and noted the following reasons for the low score:

- Aims and objectives are not clear
- Need for the project has not been evidenced
- Majority of match funding is not secured for the project
- Project does not demonstrate additionality for Copeland
- The in-kind funding is not clear
- Project start date is before CCF decision date applicant will need to update.

# Ravenglass Railway Museum: La'al Ratty Revival

The applicant is requesting an increase in grant of £10,846.08 bringing the CCF total contribution to £58,646.08 which would be an intervention rate of 36.9%. The Panel recommended approval of this increase in grant but as this would now put the grant in the large grant category the Panel requested that an email be sent to the Board to recommend approval of this additional grant.

# Regen North East Copeland: Community Lengthsman Initiative

The project is due to finish end of April 2016. The project is currently forecast to be underspent by £2,119.66. The applicant has requested that they use part of this underspend to purchase a bench for each parish (7 in total) as part of the legacy of the lengthsman project. Panel agreed to the purchase of 7 benches at a cost of £225 each, totalling £1,575.00, the remaining underspend will not be claimed. Panel requested that a plaque be installed on each bench showing Copeland Community Fund support for the project.
