### 11. AOB

Declaration of interest - HA raised a point regarding staff members being involved in Boards of groups. Panel agreed that HA is to hold a file with staff declaration of interest information using CBC template.

Governance meeting – HA has had some difficulty in organising a date where all members are available. Panel agreed that there was no urgency for a July meeting and agreed for the next meeting to be in September. A recommendation is to be taken to the July Board

proposing that if one independent member cannot attend the governance meeting then they can be substituted by another independent board member.

Egremont Youth Partnership – HA gave an update on the project. The project has been delayed due to delays with the purchase of the hall, which was a special condition of the CCF grant. HA asked the Panel to remove this condition to allow the project to progress. Panel approved.

West Cumbria Site Stakeholders Group – HA raised a query around a recent article in the Whitehaven News where a £35k annual grant pot 'for community initiatives within a 15 mile radius of the LLWR' was mentioned. The way the article was written suggested this pot as being part of the £1.5million paid into the CCF. Elaine clarified that this pot of money of £35k is held by the LLWR and has nothing to do with the CCF money.

Drigg – HA circulated a copy of an email received from John Jennings at Drigg, stating that they are unable to accept the monitoring proposal agreed at the June Board meeting. The Panel discussed and delegated HA and SB to discuss further with the applicant. The Panel agreed that the current monitoring process could continue until the applicant has new processes in place.
